Vocational Rehabilitation Providers

This is a listing of vocational rehabilitation organizations, registered with the Department of Consumer and Business Services to provide return-to-work help to injured workers. Each entry includes the firm's name, address, phone number, contact person, and the services offered. Organizations are listed by their address. Service areas are not necessarily limited to the city under which the listing appears. Be advised that an organization may not be able to provide the full range of services from each office location.

The following is a description of the services that may be offered:

- ❖ "All eligibility determination and vocational assistance services" means a firm can offer the full range of vocational assistance – eligibility determination, vocational evaluation, on-the-job evaluation, direct employment plan development, job analysis, labor market survey, job search skills, return-to-work follow-up, training plan development, and training progress monitoring.
- ❖ "Return-to-work specialist services" means a firm can provide job search skills instruction; job development; return-to-work follow-up and labor market survey follow-up and labor market survey; and can determine eligibility for vocational assistance except where such determination requires a judgment as to whether the worker has a substantial handicap to employment.

The firms are indexed first by city, followed by an alphabetical listing.
